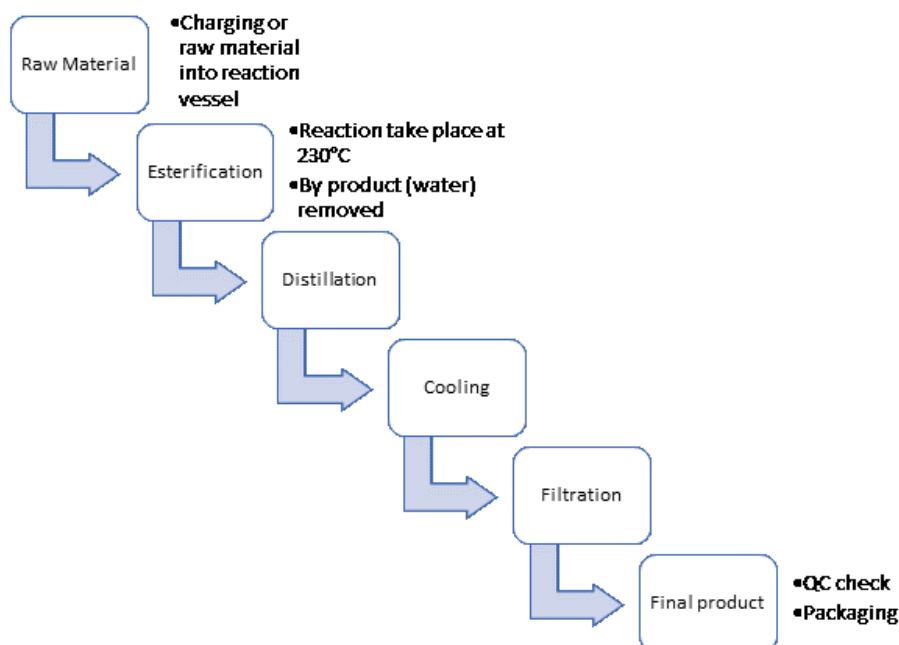

15. Naphtol Statement

For the production of this product no Naphtol were used hence the product itself do not contain any Naphtol traces.

Paraben and Ethanol have not been added to this product manufacturing process.

17. Heavy Metals, Phthalates & SVHC Statement
