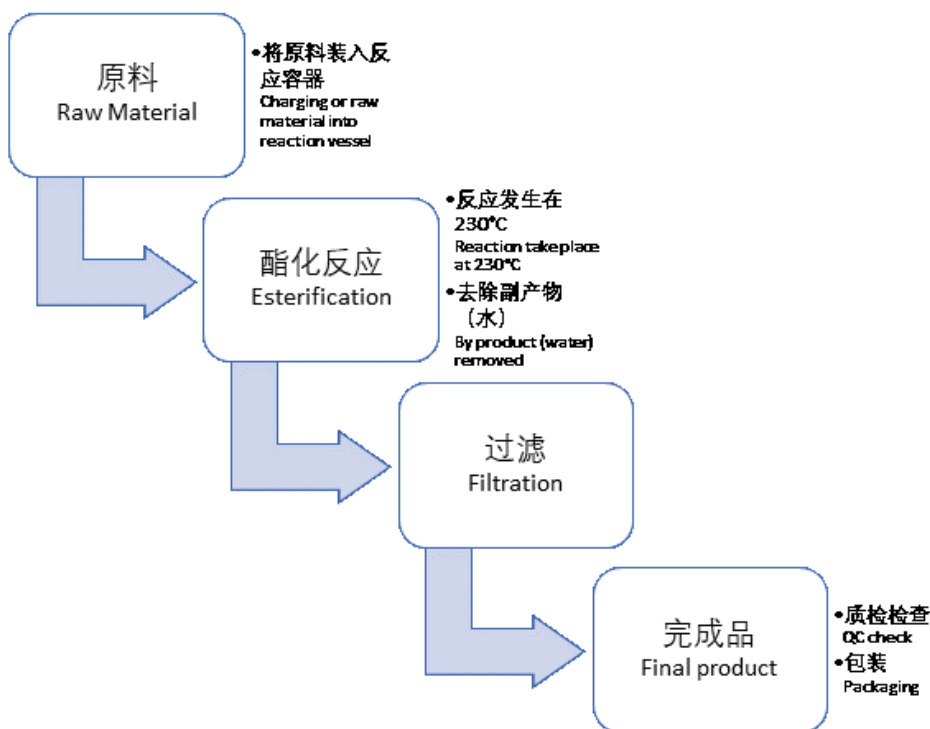

#### 4. BSE/TSE 声明 BSE/TSE Declaration
