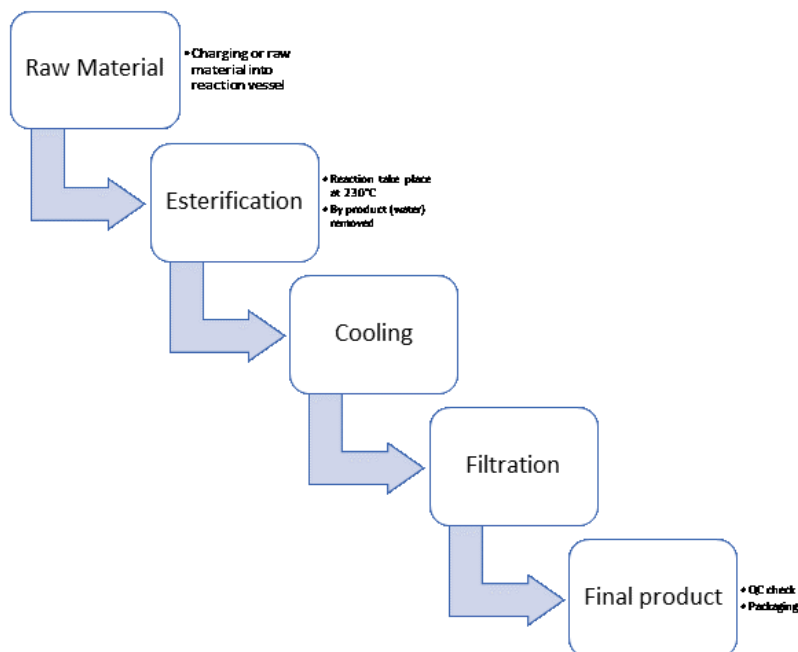

We can confirm that substances of animal origin are not used as precursors in the manufacture of this product. Such compounds are also not added to the finished product and the finished product do not come into contact with such substances within our company.

5. CMR Statement

This product does not contain intentionally added substances classified and listed as CMR category 1A/1B substances listed in Table 3.1 or CMR category 1, 2 and 3 in Table 3.2 of Annex VI to Regulation EC No. 1272/2008 (CLP Regulation) as amended.

6. Gluten Free & Dye Free Statement

For the production of this product there were no raw materials containing gluten or dye were used. Hence the product itself is gluten and dye free.

7. **Vegan/Vegetarian Statement**

For the production of this product no animal products were used hence the product itself do not contain any animal products. The product is qualified as Vegan/Vegetarian.

8. **Non-Animal Test**

This product has not been the subject of animal testing or retesting for cosmetic purpose by or on behalf of our company.

This product is confirmed as not containing, consisting or produced from Genetically Modified Organism (GMO).

11. **Halal Statement**

Do not contain pork or animal derived ingredients and ethyl alcohol. The product is produced based on raw materials from vegetable origin only and any processing aids used will be from Halal source.

12. **Kosher Statement**

Do not intentionally add, nor manufacture products at locations that contain animal, milk or grape derived ingredients.

13. **Impurities Statement**

This product does not any additives such as antioxidants, and is produced without the addition of processing aids such as catalyst throughout the esterification process.

14. **Nano Material Statement**

This product is manufactured through esterification process. There are no nano material products involved throughout the process. Therefore, we can certify this product has no concern about the nanomaterial issue at the moment.

15. **Naphtol Statement**

For the production of this product no Naphtol were used hence the product itself do not contain any Naphtol traces.

16. **Paraben & Ethanol Free**

Paraben and Ethanol have not been added to this product manufacturing process.

17. **Heavy Metals, Phthalates & SVHC Statement**

Based on our best knowledge of manufacturing process, control and handling of the material, the typical value of heavy metals content in above products are below allowable limit (Arsenic, Cadmium, Cobalt, Lead, Mercury, Nickel, Antimony, and Chromium). For specific requirement please contact us.

This product does not contain intentionally added substances of very high concern or any phthalates or materials that contain phthalates throughout the production process.

18. Nagoya Protocol

The raw materials of this product are not in the scope of the Nagoya Protocol.

19. Microplastics/Microbeads Issue

This product is manufactured through esterification process. Therefore microplastics/microbeads are not found in the end product. So, we can certify this product has no concern about the microplastics/microbeads issue at the moment.

20. Regulatory Conformity to Proposition 65

According to the requirements of Proposition 65 — “The Safe Drinking Water and Toxic Enforcement Act 1986” the product delivered under the trade name Reflez SOL 40 complies with the requirements of mentioned regulations.

21. California Safe Cosmetics Act Statement

23. DEA (Diethanolamine) Statement

DEA is not intentionally added to this product. None of the following substances are used as raw materials or generated during the manufacturing process: Diethanolamine (DEA), Cocamide DEA, Lauramide DEA, and DEA-Cetyl Phosphate.
